Region Camp Notes:

Meals: Light breakfast items and lunch is included in the registration fee. Dinner is NOT included.

Certifications: Depending on the number of candidates, we hope to do all D testing on Saturday afternoon and the C testing on Sunday. With regards to cost, D1 is considered one test and is \$25 and D2 is considered one test and is \$25. D3 and up consists of three separate tests (Horse Management, Flat and Jumping). Each test is \$25 so for example if you are doing a complete D3 the cost is \$75.

Medical armbands must be worn by campers at all times. Camp organizers do not have your medical information; therefore these are essential. If you have medical concerns or prescription medication be sure to advise your chaperone. If you wish to disclose such information to the organizers, please contact Sarah Deal.

Footwear for work around the barn and horses hard sole shoes must cover ankle and toes – wearing tennis shoes is not allowed in the barn. Sturdy muck boots are ok.

Shorts: Campers are encouraged to change into shorts when not riding at the barn.

Riding attire that shows preparedness (weather gear) and respect for instructors. Helmet, breeches, clean boots, riding and polo shirts, sleeveless shirts with collar, or collarless shirts with sleeves required for day and evening activities (Example: Tank tops of any description are NOT allowed, no bare midriffs)

Stall Cards – make ‘em, bring ‘em, post them, along with feeding instructions for your mount.

Tack and Feed Rooms – shared tack and feed rooms will be assigned like rally – but without ‘required equipment’! Coolers with beverages are encouraged.

Parent opportunities – Horse Management training, unmounted speakers, become a Horsemaster and ride at camp!

CHAPERONES are Required: Campers under age 18 must have a designated chaperone for the entire camp period. Campers age 16-17 need a designated chaperone (just as for rallies) and may only drive as allowed by NC/SC Law. Campers age 12-15 should have an onsite chaperone for the duration of camp with no more than 6 campers to a chaperone. Campers age 10-11 should have on site chaperone with no more than 4 campers to a chaperone. Campers under age 10 should have a parent at camp with them with no more than 2 young campers per parent. Parents and chaperones are welcome in the barn and should assist younger campers with their daily schedule. Seek assistance with horses as needed!
